## WORDS FROM THE CHAIR

Dear Friends,

A busy week lies ahead of us, culminating on Thursday with the hearing of Mr Virginijus Sinkevičius, Commissioner-designate for Environment and the Oceans, and who if confirmed will be responsible for the fisheries portfolio whether it is in his job title or not. We shall listen to the answers he gives and weigh up every nuance before passing judgement.

The new European Maritime and Fisheries Fund (EMFF) 2021-2027 will be at the heart of the debate in the regular Committee time. We shall consider what has been achieved in practice under the current EMFF, and how the new fund might promote better fishing and better conditions for fishers. At first reading the last Parliament approved the report with a very large majority, but the European Commission tells us that the amendments adopted would lead to an increase in fishing capacity, undermine the sustainability principle of the Common Fisheries Policy, and weaken the EU's position in trying to negotiate a global end to subsidies that harm the environment, so it is not without controversy.

We shall hear about the state of fish stocks in the Mediterranean and the Black Sea. It is not likely to be happy news, with both said to be overfished to a degree that will rob coastal communities of their reason for existence unless better management is introduced. What more must we do to turn this around? We shall also discuss the potential for marine protected areas to protect ecosystems and provide fish nurseries that can help restock our depleted seas.

Finally, we will have what I hope will be an interesting exchange with scientists from ICES. We refer all the time to the need to rely on scientific advice when setting TACs and quotas, but how does the work get done in practice, and why do the scientists sometimes get it so wrong?!

## FISHERIES NEWS IN BRIEF

### EUROPEAN PARLIAMENT

#### **Parliament voices strong concern over Brexit uncertainty for the fishing sector 24/09/2019**

**The Committee on Fisheries held a debate with Commission representatives on the level of preparedness for changes to the EU fishing sector in the event of Brexit.**

In light of the continued uncertainty regarding an orderly withdrawal of the UK from the EU, the Fisheries Committee asked the Commission for a comprehensive overview of their “Brexit preparedness” strategy for the sector.

Commission representatives presented an updated legislative proposal on a simplified procedure for granting fishing authorisations, subject to the principle of access reciprocity, which would extend the contingency measures to 31 December 2020. The Commission underlined that the actions taken are unilateral preparedness measures, aiming to ensure that EU fishermen are protected in the short term.

The main concern raised by MEPs was the lack of certainty for the entire sector, especially with regards to the reciprocal access to EU and UK waters, with only five weeks to go before Brexit is set to take place. All fishermen and other economic actors, irrespective of their nationality, are looking for answers as to how their operations will be impacted immediately after the UK’s withdrawal. It was noted that this uncertainty has been fueled by the lack of concrete reaction from the UK government on the matter.

MEPs are extremely worried by the immediate prospect of conflict in the event of a “no deal” Brexit, combined with a closure of UK waters, as well as the negative economic impact on jobs and welfare of coastal communities.

#### ***Background***

The Commission tabled on 4 September an updated draft regulation to adjust one of the EU’s ‘no-deal’ contingency measures concerning the fishing sector. The Fisheries

Committee will decide in its next meeting on 2-3 October whether to adopt this regulation along a simplified procedure without amendment. The draft regulation is set to be approved by the EP plenary meeting during the October II session.

Member States carry out fishing activities at a value of €585 million in the United Kingdom waters. The overall dependency of eight Member States (Belgium, Denmark, France, Germany, Ireland, Spain, Sweden and The Netherlands) on UK waters averages 14% of their overall landings, ranging from 50% for the Belgium fleet to around 1% for Spain.

#### **Finnish Presidency outlook and State of the Seas**

**04/09/2019**

**The Committee on Fisheries debated the Finnish Presidency work programme and the state of fishing stocks in the North Sea, Baltic Sea and Western Waters.**

Agriculture and Forestry Minister Jari Leppä presented Fisheries Committee MEPs with the key priorities for the Finnish Presidency of the Council in the field. These include the implementation of fishing efforts (Total Allowable Catches and quotas) and the corresponding multiannual fisheries plans, as recently agreed, with particular focus on preserving cod stocks.

The Presidency will also work on overhauling the [European Maritime and Fisheries Fund](#), on which negotiations with member states are expected to start as part of the 2021-2027 budget framework, to reduce red tape and improve funds allocation. The fight against illegal fishing and enhancing the role of regional fisheries management organisations were the other two priorities outlined.

MEPs called for the social impact of reforms to be taken into account when talking about making the sector more sustainable and called for funds going to the EMFF not to be cut, even after Brexit takes place. The Minister reassured MEPs on the first point and committed to work to find a fair balance on the EMFF. Members also questioned the Presidency on international fisheries agreements, namely the soon-to-

expire deal with Mauritania as well the ones with Guinea-Bissau and Morocco, all of which represent important opportunities for the EU fleet.

### ***State of the Seas***

During the second part of the meeting, committee members held an exchange of views with European Commission representatives on the state of the stocks, with a special focus on the North Sea, Baltic Sea and Western Waters.

Members welcomed the overall progress, with 59 out of 81 assessed species achieving sustainable levels and an increase in the marine biomass volumes of 36% over the past 15 years, according to the Commission. While the EU fishing fleet is shrinking slightly, their economic performance reached record levels in 2017.

Nevertheless, fishing pressure on Western Baltic Haring and Western Baltic cod needs to decrease significantly for stocks to recover. Fishing of Eastern Baltic cod, which is suffering also from ecological factors, should stop completely and so should the fishing of haring West of Scotland, says the Commission. Overall, member states should step up controls of the new landing obligations and allocate more resources to scientific research to assess stocks, also beyond the 81 species currently assessed (out of some 200).

Committee Chair Chris Davies (Renew Europe, UK) said: 'Year by year, the fish in the seas of northwest Europe are increasing in numbers and sizes. We have problems in individual fish stocks that must still be address but the CFP is at long last showing signs of success'

Some MEPs asked the Commission to engage in a more holistic approach - including environmental factors - when assessing stocks and deciding on remedies. Others wondered how the EU can prevent putting fishermen out of business due to drastic and sudden changes in quotas. Furthermore, they would like to hear from the Commission about plans on how to to mitigate the impact of Brexit on EU fishermen in one of the next committee meetings.

## **The European Fisheries Control Agency (EFCA) trains Gambian fisheries inspectors**

**24/09/2019**

**Twenty fisheries inspectors from the Republic of The Gambia received training in control techniques to fight and deter Illegal, unreported and unregulated fishing (IUU).**

The training ended with a practical exercise in the fishing port of Banjul, allowing fisheries inspectors from The Gambia to discover new methods of fisheries control and to become familiar with EFCA's e-learning platform.

The theoretical and practical training was organised in the framework of the PESCAO programme, financed and implemented since 2018 by the European Union.

Fisheries inspectors from various Gambian administrations needed to become familiar with the different techniques and applicable regulations, in the context of the recent membership of the Republic of The Gambia to the [International Commission for the Conservation of Atlantic Tunas \(ICCAT\)](#) and the sustainable fisheries partnership agreement signed with the EU.

## **Largest polar expedition ever will map climate and marine ecosystems in central Arctic ocean**

**20/09/2019**

**The Polarstern icebreaker will embark on a year-round expedition to study climate change in the Arctic. On board is a team of scientists, supported by the EU, who will conduct pioneering research on the marine ecosystems of the central Arctic ocean. The results of their expedition will improve our understanding of these ecosystems and help us determine whether fish stocks might exist in this area that could be harvested on a sustainable basis.**

The MOSAiC (Multidisciplinary drifting Observatory for the Study of Arctic Climate)



expedition is the largest polar expedition to date. The backbone of the expedition is the German research vessel Polarstern, which will spend a year drifting through the central Arctic ocean while attached to an ice floe. Hundreds of researchers from 19 countries will visit the Polarstern during this year to conduct research and gather data to gain a better understanding of global climate change.

Among them are scientists from the EU-funded consortium European Fisheries Inventory in the Central Arctic ocean (EFICA). This international consortium will map marine ecosystems in the area. Little scientific data exists on this subject, particularly from wintertime.

The work of the scientists will support the implementation of an international agreement to prevent unregulated high seas fisheries in the central Arctic ocean. This agreement takes a precautionary approach to potential medium or long-term fishing opportunities in the area. No fisheries can take place, until scientific evidence exists that it can be done sustainably. Building scientific knowledge on marine ecosystems in the central Arctic, including which marine living resources exist in it, is therefore a logical first step.

The EU is one of the first parties to the agreement to set up such a research expedition.

### Exchanging information leads to more effective actions at sea: CISE

17/09/2019

**Improving the coordination between maritime authorities and across borders is a long-winded work. The key to success is interoperability: the technical ability to exchange information between systems that were developed completely independent from each other. The EU's Common Information Sharing Environment (CISE) is doing exactly that, and just last week, the European Commission has released a staff working document to present its progress so far.**

CISE, initiated in 2014, is gradually taking shape. Important interoperability projects, including [EUCISE2020](#) and national projects,

have been successfully completed. And as CISE develops, it helps to bring about a significant political mentality change. National and EU maritime authorities have come to realise that, by cooperating in exchanging information, they can work more efficiently and effectively.

CISE is now ready to develop from an R&I product into an operational environment for structural information exchange. The [transitional phase to operations](#), managed by EMSA, will enable further coordination in the next two years. Further reflection will be necessary, also at political level, to make CISE fully operational and successful. The Commission intends to support CISE also under the next EMFF.

## EU and China join forces to improve international ocean governance

10/09/2019

**At the first Blue Partnership Forum for the Oceans (05/09/2019), the European Commission and Chinese authorities have shown their eagerness to work together and improve international ocean governance. Together with Chinese and European stakeholders, both administrations have started to define joint actions that will implement the Ocean Partnership, signed in July 2018.**

The Ocean Partnership between the EU and China marks an important moment in our bilateral relations. Its implementation can play a major role in achieving the targets of the 2030 Agenda for Sustainable Development, in particular SDG 14. We can look back on a very successful event. A few first conclusions:

1. **The blue economy and the Blue Economy Finance Principles** – Stakeholders agreed more direct investments should go into sustainable oceans sectors and ecosystem restoration. Financial institutions play a crucial role in directing financial flows. The Blue Economy Finance Initiative and Principles are a practical tool for them to deliver ocean solutions.
2. **International cooperation on sustainable fisheries** – China and the EU are important global fisheries players. Actions should reinforce the implementation of the existing legal framework, including ratification of the

Port State Measures Agreement, enhancing RFMO performance, strengthening the fight against IUU fishing and strengthening fisheries data transparency.

3. **Area-based management tools**, including maritime spatial planning and marine protected areas – Participants stressed that different sectors (science, business, public organisations, NGOs...) need to work together when developing these tools. EU and China should strengthen cooperation in the planning of marine protected areas and advancement of global maritime spatial planning. EU stakeholders called on China to support the EU and its Member States' proposals to create two marine protected areas in the Southern Ocean at the annual meeting of the Commission for the Conservation of Antarctic Marine Living Resources in October this year. ## Sustainable fisheries: EU and The Islamic Republic of Mauritania extend existing protocol

04/09/2019

**The EU and the Islamic Republic of Mauritania have agreed to extend, for maximum one year, the protocol to the sustainable fisheries partnership agreement which was due to expire in November 2019.**

Under the protocol, the EU fleet can fish in Mauritanian waters for shrimp, demersal fish, tuna and small pelagic fish, up to a total of 287,050 tons a year. In addition to the fees paid by the European fleet, the EU pays a financial contribution of €61,625,000 per year, comprising of €57,500,000 for the access to waters and €4,125,000 for supporting local fishing communities in Mauritania and improving fisheries governance.

This extension fully reflects the existing protocol and confirms its underlying principles. It will allow for the continuation of fishing activities of EU operators in Mauritanian waters as of 16 November 2019. Meanwhile, the negotiations for a new agreement and protocol will continue.

The two parties agreed on an exceptional derogatory procedure to tackle potential border blockages during the export transportation of fresh fish caught in Mauritanian waters.

The extension will enter into force when the necessary legislative procedures for its conclusion have been completed.

**European Commission pleased with progress international negotiations to protect high seas – ambitious final agreement needed by 2020**

**03/09/2019**

**The European Commission looks back on very constructive negotiations with international partners to protect the marine biodiversity in areas beyond national jurisdiction – commonly called the high seas.**

These negotiations, held under a United Nations Intergovernmental Conference, should lead to international rules for marine protected areas as well as for assessing the environmental impact of activities carried out in the high seas. They will also help use the high seas' biological resources – in particular its genetic resources – in a more sustainable way.

Positions on several key issues continue to diverge, in particular on the marine genetic resources and capacity building and transfer of marine technology parts. Nevertheless, a vast majority of delegations are now fully committed to the process, submitting a large number of textual proposals.

With regard to environmental impact assessments, the idea of assessing the cumulative impacts from different activities on the same ecosystems seemed to receive near unanimous support. The EU proposal to include a provision on Strategic Environmental Assessments is gaining traction.

The EU will now continue to work towards a final agreement by 2020. The European Commission will organise a workshop on environmental impact assessment and strategic environmental assessment in Brussels during the second half of January 2020. Some EU Member States are also planning to organize

workshops in support of the negotiations. [Read more](#)
